## LOCATION

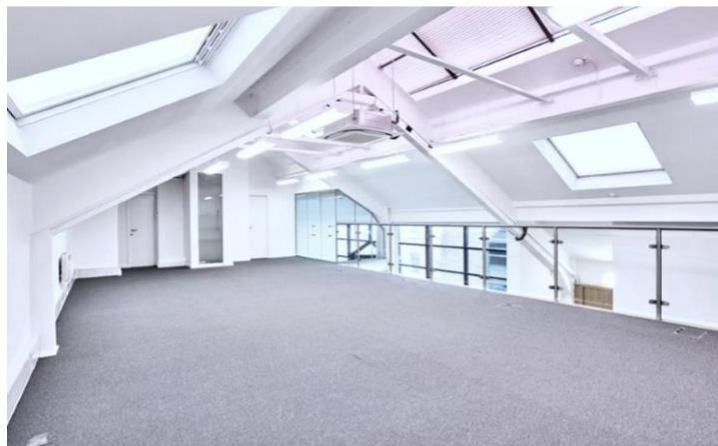
Fulham Road is an affluent and internationally recognised urban centre in the London Borough of Chelsea and Westminster, located approximately 3.7 miles south west of Central London.
